The data-base is registered under the UK Data Protection Act which means that you have the right to access the information about yourself as a Data Subject but you have no automatic right to access any other information. The Blo(o)r(e) Society also holds information on individuals who are no longer alive, which is not subject to the Data Protection Act, but we have taken the decision that we will not disclose any of this information except to individuals who want the information for their own private genealogical research. It is a condition of membership of the Society that you give an assurance, which you do by signing this membership application, that you will use any information disclosed to you by the Society, whether it relates to a living person or to a person no longer alive, only for your own private genealogical research and not for any commercial purpose. You should pass the information only to individuals who will give you a similar assurance. If you are approached by any organisation seeking information which has been disclosed to you by the Society then you should advise them to contact the Society directly at the address given at the top of this form. Any member who is found to have breached this rule may be excluded from membership.
